

FACTS**WHAT DOES AmeriHome DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- **Social Security number** and **Payment history**
- **Income** and **Account balances**
- **Credit scores** and **Credit history**

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **Customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers'** personal information; the reasons **AmeriHome** chooses to share; and whether you can limit this sharing.

How does AmeriHome protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does AmeriHome collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ▪ Pay your bills ▪ Give us your income information ▪ Open an account ▪ Give us your contact information ▪ Provide employment information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies</p>
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes — information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ AmeriHome has no affiliates.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ AmeriHome does not share with non-affiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ▪ AmeriHome does not jointly market.
Other important information	
<p>Do Not Call Policy: This notice is the AmeriHome Mortgage (in AZ, DBA AmeriHome Funding) Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows. AmeriHome employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from AmeriHome will be placed on the AmeriHome Do Not Call list and will not be called in any future campaigns. To be placed on our marketing Do Not Call list, please call 866-792-6902. If you communicate with us by telephone, we may monitor or record the call.</p> <p>California Residents: We will not share information we collect about you with companies outside of AmeriHome, unless the law allows. We may share information for example, with your consent, to service your account, or to report to credit bureaus.</p> <p>North Dakota Residents: We will not disclose nonpublic personal information except as permitted by N. Dakota law. We will not disclose any nonpublic personal information to nonaffiliated third parties except through either your opt-in election or through other permitted exceptions, such as to maintain or service your account or to a consumer reporting agency.</p> <p>Vermont Residents: We do not disclose nonpublic personal information about customers or former customers to non-affiliated third parties except as permitted by Vermont law.</p>
